1. Programme Qualification Profile

Fundamental philosophy, values, academic and methodological profile of the programme

The objective of the Bachelor's programme International and Diplomatic Studies is to prepare economists for the area of international economic relations and provide them with theoretical and methodological knowledge, as well as extensive language skills. The programme is designed so that students acquire a comprehensive knowledge of the current international practice. The study of international economic relations is multi-disciplinary connected with extensive education in general economic and management disciplines, International Relations, Law, History as well as quantitative methods. The essential values of the programme include showing respect for the ethical dimension of diplomacy, readiness to work in a multicultural environment and the ability to respond to changing conditions of the globalising international economic relations.

Profile of students suited for the programme

The program is suitable for linguistically talented students prepared to grasp a complex knowledge who want to work in a multicultural environment and are interested in international relations.

Graduates' profiles, labour market and job opportunities

Programme graduates will acquire interdisciplinary knowledge that the current international practice requires. They may find employment in the apparatus of foreign services, mass media, middle management of European or international political and economic institutions and organisations, or work as assistants in the international institutions of the state administration, as international project managers in non-governmental organisations, UN Agencies and other international governmental and non-governmental institutions at lower and middle managerial levels.

2. Learning Outcomes

Professional know-how

A graduate:

- ✓ has interdisciplinary knowledge of International Relations (International Politics, International Economy, International Law and International Security) and multicultural issues including ethical aspects;
- ✓ comprehends principles of World Economy, financial markets, behaviour of economic entities, understand causes of market failures and possible solutions;
- ✓ knows elementary mathematical apparatus, basic probability theories, descriptive statistics and information technology;
- ✓ knows the structure and principles of foreign services and international institutions, know diplomacy, diplomatic practice and protocol, know state political systems and their foreign policies, and know the law, especially International Law;
- ✓ is able to apply major theoretical concepts in the area of International Relations
 (International Politics, International Economy, International Law and International)

- ✓ identify main characteristics and tendencies of international development and clarify causes and contexts of current international conflicts, and apply knowledge of International Law, diplomatic protocol, principles of international negotiations and intercultural communication;
- ✓ make managerial decision independently using basic tools of marketing and financial management and apply business processes to the cases in changing international environment;
- ✓ communicate in oral and written form at least in two world languages at the C1 level of Common European Framework of Reference for Languages in the field of International Relations;
- ✓ apply knowledge of individual management models of foreign services and
 cooperation of various actors, implement the analysis of political, economic, legal,
 cultural and security situation in a particular country, and apply in practice knowledge
 of foreign relations management, diplomatic communication and International Law;
- ✓ establish relations with foreign partners, lead negotiations and present views, both to
 partners and media, contribute to the self-presentation of state.

It is highly recommended to realise study abroad or internship either during the 4th or the 5th semester. For their study abroad, students should prefer a partner university that offers International Relations, International Studies or Political Science programme(s) and enrol classes that can be recognised as compulsory courses (oP) in accordance with their study plan if possible. The recognition of a course taken at the partner university can be assessed by the guarantor of the relevant course at the University of Economics, Prague, before the semester abroad, based on a request submitted through the InSIS Contact Centre and supplemented by a syllabus of the subject from the partner university, or a functional and freely accessible link to the syllabus on the partner university's website.

- Department of International and Diplomatic Studies
- Department of International Economic Relations

A bachelor's thesis seminar must be successfully completed in the semester that precedes the semester, in which the thesis is to be defended.

Bachelor State Exam

The bachelor state exam is a comprehensive verification of the ability to elaborate in a written form the thesis on a given topic systematically and independently.
